I will ensure that a copy of the form EGKA AD001c <u>Conditions of Use</u> is given to each and every pilot(s) authorised on EGKA-101b and that they are named on the form and sign to acknowledge their obligations. I will obtain before any Indemnity or out-of-hours flight from each and every pilot a signed acknowledgement that they have received a copy of such terms & conditions.
 - a. I understand that no pilot is to operate under the Indemnity Scheme or out-of-hours conditions unless the conditions in paragraph 1 above and this paragraph 2 are followed.
- The said conditions apply to and govern each and every movement by my aircraft at BCAL under Indemnity or out of hours conditions and I will be responsible for all or any breaches of the said conditions by the pilot or pilots of my said aircraft.
- 4. The aircraft to which this permit relates will carry Third Party Legal Liability insurance in the sum of not less than £3,000,000 and I will, if required, produce evidence of such insurance to BCAL staff on demand.
- 5. If I sell or dispose of the aircraft, I will immediately notify BCAL and acknowledge the permit is not transferable.
- 6. I agree to indemnify BCAL in respect of all claims, actions, demands, liabilities or judgements whatsoever arising out of, or in any way connected with, the use of BCAL by the said aircraft under Indemnity or out of
